INTRODUCTION AND FIRST READING OF ORDINANCES AND RESOLUTIONS**ITEM 1.**

An Ordinance authorizing the Mayor to execute an Amended and Restated Redevelopment Agreement with **Generation II Development Services, L.L.C.**, under which the City will convey (1) approximately sixteen (16) parcels of property located at 1650–1808 Shuttlesworth Lane, Birmingham, Alabama and (2) property known as McArthur Elementary School, located at 2418 17th Avenue, North, Birmingham to Generation II Development Services, L.L.C. each for a use value of \$1.00 and Generation II Development Services, L.L.C. will develop affordable housing to consist of sixteen (16) energy-efficient, three-level townhouses and fifty-six (56) cluster homes for affordable senior housing. A Resolution of intent to support (I) the extension of the City's pledge to the **Birmingham Jefferson Civic Center Authority (BJCCA)** of \$3,000,000.00 per year of the proceeds of the City's occupational tax and two-thirds of the City's annual lodging tax revenue, which is based on the City's current lodging tax rate of three percent (3%), not to exceed \$2,000,000.00 per year, to provide funding for the development of a new four-star convention-style hotel under the "Westin" brand with approximately three hundred (300) guest rooms and related meeting rooms, restaurants, a pool and exercise facilities and parking improvements, and approximately 60,000 square feet of storefront space to be leased to businesses such as restaurants, music clubs and retail shops, and authorizing the Mayor to commence negotiations of agreements with the BJCCA as are necessary and appropriate to provide for the City's financial support of this project and to present such agreements to the Council for consideration and approval, and (ii) an increase in the rate of the City's lodging tax by 3.5% in order to provide for development of sports and entertainment facilities to complement the City's Railroad Park and to expand the City's tax base, to create jobs and to increase tourism.
