Mayor Langford reminded the public that City Hall will be closed Friday, July 3rd.

Mayor Langford announced that the City of Birmingham has received the Debt Service Award.

Mayor Langford announced that the Fair Park Renovations and Improvements are underway and presented the Council with a packet which includes a DVD of the upcoming renovations and improvements.
