### INVITATION TO BID # 15-36

Sealed bids for dress and casual uniform items for various departments for one (1) year, and month to month thereafter, will be received by the Purchasing Agent, P-100 First Floor City Hall, Birmingham, Alabama until 2:00 p.m., June 10, 2015, at which time and place they will be publicly opened and read.

Bidders wishing to bid can download the complete solicitation including the specifications and bid forms via the internet at [www.birminghamal.gov](http://www.birminghamal.gov) (go to link titled **Bidding Opportunities**), or by visiting the Purchasing Office at the address shown above, or by calling (205) 254-2265, fax (205) 254-2484 and requesting a copy be mailed to you. Any addenda will be available on the internet. Bidder is responsible for checking the website for addenda until the bid opening date. Addenda will be mailed to only those vendors who were provided a copy in person or by mail.

All bids are to be submitted on the bid form provided and all bids are to be f.o.b. Birmingham, Alabama delivered.

It is required for any contract exceeding \$10,000.00 that the bidder submits with his bid a certified check, a cashier's check, or a bid bond payable to the City of Birmingham. In order for any bid award to be considered that exceeds \$10,000.00, your bid must be accompanied by an acceptable bid bond or check in the amount of \$500.00. Bid bond checks will be returned to all unsuccessful bidders after the formal award is made and to the successful bidder after acceptance of award. Should the successful bidder fail to accept the award, the bid bond check shall be forfeited.

The City follows a policy of nondiscrimination. No contractor with the City should discriminate on the basis of race, sex, religion or national origin. Failure by the Vendor to carry out these requirements is a material breach of its obligations, which may result in its termination or such other remedy as the City deems appropriate.

No bid may be withdrawn for a period of sixty (60) days after the date of the bid opening.

The City reserves the right to reject any or all bids submitted in whole or in part, and to waive any informalities.

Bids must be submitted in a sealed envelope marked, "SEALED BID – DRESS/CASUAL UNIFORMS" - 2:00 P.M., 06/10/15." Bids may be hand delivered to Room P-100 First Floor City Hall, Birmingham, Alabama or mailed to City of Birmingham, P.O. Box 11295, Birmingham, Alabama 35202-1295. **(DO NOT MAIL BIDS TO ROOM P-100 1ST FLOOR CITY HALL)**. However, bids sent by any express carrier (i.e. Federal Express, UPS, Airborne, etc.) must be shipped to 710 North 20th Street, and specify delivery to Room P-100, 1st Floor-City Hall.

It is the bidder's responsibility to make sure that his bid is in the possession of the Purchasing Agent on or before 2:00 p.m., June 10, 2015. Bids received after this time will not be considered.

## SPECIFICATIONS

The specifications in this document describe the dress and casual uniforms the City of Birmingham plans to use for various departments. The quantities listed on the bid form represent an estimated annual usage and are for evaluation purposes only. All items will be bought throughout the year on an as needed basis. No guarantee is made as to the exact number of any item to be purchased; quantities may be more or less than the quantities shown.

Successful bidder(s) shall be required to furnish a thirty (30) day advance notice if vendor is not able to hold their price past the one (1) year period, or any month to month extension thereafter.

The City's standard payment terms are net 30 days from acceptance. Exceptions may be allowed for discounted early payment, such as 2% 10 net 30 days. The City will not consider any bids requiring C.O.D. payment.

Any questions concerning these specifications should be addressed to Charles Lindsey, Purchasing Division, Phone: (205) 254-2269 or Fax: (205) 254-2484, between the hours of 8:00 a.m. and 3:00 p.m., Monday thru Friday.

The contract shall become effective from the date noted in the Notification of Award letter which will be mailed to the successful vendor.

The City will issue purchase order(s) to the successful bidder for the goods and/or services (bid items) that are the subject of the bid. Unless otherwise agreed in a writing that is signed by both parties, the entire agreement between the City and the successful bidder concerning the bid items is comprised of the terms, conditions, specifications and requirements stated in (a) the contemplated purchase order(s), (b) this Invitation to Bid and Specifications and (c) your bid (collectively, the "Contract Requirements"). These writings supersede all former proposals, offers, negotiations, representations or agreements, either written or oral, concerning the provision of vendor's goods and/or services. By acceptance of the City's purchase order(s), the successful vendor agrees to abide by and perform its responsibilities related to the bid items in compliance with the Contract Requirements.

Successful bidder shall not assign this contract to any other party without prior written approval of the City of Birmingham. Contract shall not be assigned to an unsuccessful bidder who was rejected because he was not a responsive or responsible bidder.

Failure to adhere to any or all terms, conditions and specifications as set forth in the contract may result in the immediate termination of the contract. Should termination occur, the holder of the contract may be declared a "non-responsible vendor". This declaration may result in the rejection of any future bids submitted by the vendor for a period of time to be determined by the City.

Bids may be solicited for any product included in this contract where an immediate/emergency need exists, including large quantities. The decision of the Purchasing Agent as to what constitutes a biddable situation shall be final and shall not be construed as a breach of contract.

Contract award to purchase the materials covered in this bid document shall be construed under and governed by the laws of the State of Alabama and each party hereto irrevocably agrees to be subject to the jurisdictions of the courts of the State of Alabama.

Municipalities are not liable for sales tax: reference Code of Alabama Section 40-23-4. Costs normally considered pass through costs (property tax, use tax, delivery fee, set up fee, etc.) to the customer by the provider must be included in any fee proposed (Code of Alabama Section 40-12-222). For the purchase of personal property, the City's policy is to apply a local preference option as allowed by State of Alabama Code, Section 41-16-50, in determining the low bidder.

Vendor (and its employees, agents and any subcontractors) shall not discriminate on the basis of race, color, national origin, or sex in the performance of the services contemplated hereunder. Failure by the Vendor to carry out these requirements is a material breach of its obligations, which may result in its termination or such other remedy as the City deems appropriate.

Vendor acknowledges and agrees that, consistent with federal law and City's public policy, it will encourage disadvantaged business enterprise (DBE) participation to the extent permitted by law. A "disadvantaged business enterprise" is a for-profit small business concern (i) at least 51% owned by one or more individuals who are both socially and economically disadvantaged or, in the case of a corporation, in which 51% of the stock is owned by one or more such individuals; and (ii) whose management and daily business operations are controlled by one or more of the socially and economically disadvantaged individuals who own it. In accordance with federal law, a "socially and economically disadvantaged individual" includes African-Americans, Hispanic Americans, Native Americans, Asian-Americans, women, and any additional groups designated as socially and economically disadvantaged by the Federal Small Business Administration.

**Successful bidder acknowledges and agrees that the City has the right to deduct from total amount of consideration to be paid, if any, to the successful bidder under this agreement all unpaid, delinquent, or overdue license fees, taxes, fines, penalties and other amounts due the City from the successful bidder.**

**Any bidder who is not currently set up as a vendor in the City of Birmingham vendor file will be required to submit a completed W-9 tax form prior to any award. The W-9 tax form may be submitted with your bid or no later than seven (7) working days of receipt of notice of intent to award.**

**The City of Birmingham must have a copy of the successful bidder's current City of Birmingham business license prior to formal award of contract. Each bidder may submit a copy of his/her license along with his/her bid. However, bidder must provide a copy of his/her current business license no later than seven (7) working days of receipt of notice of intent to award. Failure to submit the requested information will result in the notice of intent to award being revoked.**

**Successful Vendor (located in the State of Alabama or located outside of the State of Alabama, but employs one or more employees within the State of Alabama) represents and warrants that it does not knowingly employ, hire for employment, or continue to employ an "unauthorized alien", as defined by the Beason-Hammon Alabama Taxpayer and Citizen Protection Act, Act No. 2011-535 (H.B.56) of the Alabama Legislature, as amended from time to time (the "Act") and that, during the performance of this contract, Vendor shall participate in the E-Verify program as required under the term of the Act. Vendor agrees to comply with all applicable provisions of the Act. As a condition for the award of any contract, Vendor shall provide documentation establishing that the Vendor is enrolled in the E-Verify program, or a signed, written statement that the Vendor does not have a presence (one or more employees) in the State of Alabama. Vendor may submit applicable documentation with his/her bid or no later than seven (7) working days of receipt of notice of intent to award.**

**GENERAL:**

Bids will be accepted only from established firms engaged in the business of stocking, selling or renting uniforms within the corporate city limits of Birmingham, AL and/or Jefferson County. A minimum stock of the uniform items indicated on the bid form from which the City can pick-up as needed will be required. Items not in stock that must be ordered shall be delivered within thirty (30) days of receipt of purchase order and proper size requirements, whichever is the latter. Repetitive late deliveries will be grounds for termination of the contract. However, late deliveries due to documented interference by City personnel will not be held against the vendor.

**Successful bidder will be required to measure each City employee to ensure proper fit. Bid price will include any common alterations required for proper fit: Blazer sleeve length, lower collar; Trousers and shorts – waist, seat, length; Skirts – waist, length; Shirts – no alterations. Charges for any other alterations will have to be approved by the appropriate department and billed separately. All items are to be delivered to the delivery location provided on each purchase order. Items on each purchase order are to be shipped as a complete quantity at one time – no partial shipments. Items are to be wrapped, boxed, bagged, etc. and properly identified with purchase order number and employee name, if provided.**

Items whose sizes are marked "or larger" are to be priced through manufacturer's size chart. Oversize (6XL, 7XL etc.) clothing will be handled on a case by case basis.

Specifications are written around garments manufactured on a quality level equal to Edwards Garment Co., or other manufacturer specified. Any bid submitted must be accompanied by catalogs, brochures and/or specification sheets that will adequately demonstrate the item being bid is equal or superior to that specified. Samples will be required for inspection and approval prior to formal award. Colors to be selected from standard manufacturer's selection chart – vendor is to note any minimum requirements for each item specified. Any bid submitted must have Navy Blue and Gray in blazers and dress trouser; and must have black and khaki (putty may be acceptable substitute for khaki) for all items listed in the casual section of this document.

Award will be made based on items bid by the vendor and approved by the Purchasing Division of the City of Birmingham. Vendor shall not substitute any items on this contract without formal approval of the proposed substitute. Vendor shall not exchange contract items for non-contract items. Vendor shall not allow City employees to substitute more expensive items for contract items and pay the difference or return contract items in exchange for more expensive items and pay the difference in price. Vendor is to provide exactly what is called for on each and every purchase order. Violations of this requirement shall be considered fraud and grounds for cancellation of the contract.

The City intends to award items on a group basis. Bidders may bid only groups of interest and are not required to bid all groups to be considered for award. However, bidders must bid all items in a particular group.

## DRESS UNIFORM SPECIFICATIONS

**BLAZERS:** 100% texturized woven polyester with visa soil release finish, fully lined, traditional collar and lapel, single breasted two button front, felt lined collar, angled and vented sleeves, vented back, two (2) abdominal pockets with flaps, one breast pocket, available in regular and long length styles. Women's style to be the same, no back vent or breast pocket.

Double breasted version same as above except 4-6 button front.

Wool blend blazer – same as above except a minimum 25% wool, wool/polyester blend fabric.

**TROUSERS:** (Plain and Pleated): 100% texturized polyester with visa soil release finish, full cut, hemmed straight leg, two (2) side pockets, two (2) back pockets, French fly, extension waistband, reinforced crotch, Ban-roll waist, at least eight-stitch pocketing, belt loops – 1-3/4" loops. Similar style for women with and without pockets.

Minimum 35% cotton, cotton/polyester durable press fabric trousers – same as above.

Minimum 25% wool, wool/polyester blend fabric – same as above.

**SKIRTS:** (Plain and Pleated): 100% texturized woven polyester with visa soil release finish, straight skirt, banded front, zipper and button closure, back walking vent, fully lined, with slant pockets and without pockets.

Minimum 35% cotton, cotton/polyester blend fabric skirt, durable press, same as above.

Minimum 25% wool, wool/polyester blend fabric skirt, same as above.

**SHORTS:** Minimum 35% cotton, cotton/polyester blend fabric, pleated, 1-1/2" belt loops, two (2) front pockets, two (2) back pockets, front zipper and closure, hemmed bottoms, Ban-Roll waistband, durable press. Similar women's version of the above specified shorts.

**SHIRTS:** 60% cotton 40% polyester oxford cloth. Seven (7) button front, button-down collar, reinforced inner faced collar, easy care finish, colors to be white, pastels and stripes, box pleat back, single pocket style. Similar version for women. Bid price to include both standard and long lengths.

35% cotton/65% polyester broadcloth, seven (7) button front, stay collar and button-down collar, box pleat back, easy care finish, colors to be white, pastels and stripes, single pocket style, short and long sleeve. Similar version for women. Bid price to include both standard and long lengths.

**TIES:** 100% polyester pattern, fully lined, bar tacked at both ends, fore in hand, clip-on style, and women's floppy bow tie.

**BELTS:** 1" – 1-½" men's top grain bridle leather belt not bonded or stitched. Color to be selected. ¾" – 1-½" women's top grain bridle leather belt, not bonded or stitched. Color to be selected.

**EMBROIDERY:** All bidders are asked to bid a single unit price per garment to embroider shirts, wind-shirts and jackets as needed with the wording: **Birmingham Public Works**. Wording to appear as described below:

Embroidery to appear on the left front chest area of each garment, unless otherwise stated. City reserves the right to substitute any standard stock thread color at no additional cost. Embroidery will be done by the successful bidder of each garment prior to delivery of the garment. Bidder is responsible, as stated earlier, for sizing each employee to guarantee proper fit prior to embroidery and delivery of the garments.

Embroidery can include single line text (City of Birmingham, Traffic Engineering, individual's names, etc.) and double line text as above or "Birmingham/(Dept.)". Embroidery can also include badges, shields, and the City Seal. Shields/Badges include Public Works Code Enforcement Environmental Police, Traffic Engineering Parking Enforcement, and the Museum of Art Security Personnel to include up to six (6) colors of thread. Shields/Badges and the City Seal are grouped as line items.

Shields/Badges represent metal badges and are approximately 2 ¼" x 3 ¾". The City Seal is 2 ½" to 3 ¼" depending on adjustment of embroidery machine.

**PATCH:** Sew on patch – Sew on patches provided by various depts.

Colors – Black (017) or Putty (295), Sizes – S(6-8), M(10-12), L(14-16), XL(18-20), 2XL(22-24). Dunbrooke 3415, Anvil 641, or equal. Embroidery should contrast garment color (Khaki on Black or Black on Putty) and priced separately as an add-to price.

**Women's Shirt: 8507 UltraClub® Collection Ladies' Egyptian Cotton Interlock short-sleeve V-neck Top or equal:** 100% ring-spun Egyptian cotton •5.75-oz.. •40/1 yarn, fine gauge fabric for ultimate softness • Comfortable, feminine styling • Sizes: S-2XL, Embroidery should contrast garment color (Khaki on Black or other contrasting color if a different color is chosen from the manufacturer's color chart as previously described on page 4 ) and priced separately as an add-to price.

**Women's Shirt: Port & Company® - Ladies Essential T-Shirt. LPC61 Cotton Interlock short-sleeve Crewneck or equal:** Heavyweight 6.1-ounce, 100% soft spun cotton; Shorter cut through the body and sleeves for a more feminine fit; 1x1 rib knit collar; Shoulder-to-shoulder taping; Coverseamed neck; Double-needle sleeves and hem Colors black only. Embroidery should contrast garment color (Khaki on Black) and priced separately as an add-to price.
