INVITATION TO BID #16-47

Sealed bids for ammunition and targets for the City of Birmingham for a period of one (1) year, with month to month extensions thereafter upon mutual agreement of both parties, for the City of Birmingham, will be received by the Purchasing Agent, P-100 1st Floor City Hall, Birmingham, Alabama, until 2:00 p.m., October 11, 2016, at which time and place they will be publicly opened and read.

Bidders wishing to bid can download the complete solicitation including the specifications and bid forms via the internet at www.birminghamal.gov (go to link titled **Bidding Opportunities**), or by visiting the Purchasing Office at the address shown above, or by calling (205) 254-2265, fax (205) 254-2484 and requesting a copy be mailed to you. Any addenda will be available on the internet. Bidder is responsible for checking the website for addenda until the bid opening date. Addenda will be mailed to only those vendors who were provided a copy in person or by mail.

It is required for any contract exceeding \$10,000.00 that the bidder must submit with his bid either a cashier's check, certified check, or a bid bond payable to the City of Birmingham. In order for any award to be considered that exceeds \$10,000.00, your bid must have been accompanied by an acceptable bid bond or check in the amount of \$500.00. Bid bond checks will be returned to all unsuccessful bidders after the formal award is made and to the successful bidder after acceptance of award. Should the successful bidder fail to accept the award, the bid bond or check shall be forfeited.

The City follows a policy of nondiscrimination. No contractor with the City should discriminate on the basis of race, sex, religion or national origin. Failure by the Vendor to carry out these requirements is a material breach of its obligations, which may result in its termination or such other remedy as the City deems appropriate.

Bids are to be submitted **on the bid form provided** and all quotations are to be f.o.b. Birmingham, Alabama delivered.

No bid may be withdrawn for a period of sixty (60) days after the date of the bid opening.

The City reserves the right to reject any or all bids submitted in whole or in part, and to waive any informalities.

Bids must be submitted in a sealed envelope marked, "**SEALED BID - AMMUNITION - #16-47; 2:00 P.M., 10/11/16**". Bids may be hand delivered to Room P-100 1st Floor City Hall, Birmingham, Alabama, or mailed to City of Birmingham, P.O. Box 11295, Birmingham, Alabama 35202-1295. (**DO NOT MAIL TO ROOM P-100 1st Floor CITY HALL.**) However, bids sent by any express carrier (Federal Express, UPS, Airborne, etc.) must be shipped to 710 North 20th Street, and specify delivery to P-100 1st Floor City Hall.

It is the bidder's responsibility to make sure that his bid is in the possession of the Purchasing Agent on or before 2:00 p.m., October 11, 2014. Bids received after this time will not be considered.

**SPECIFICATIONS FOR THE SUPPLY OF
AMMUNITION AND TARGETS FOR THE BIRMINGHAM POLICE DEPARTMENT**

GENERAL: The City of Birmingham is seeking bids for ammunition and targets for the Birmingham Police Department. The basis of the bid shall consist primarily of any and all ammunition and target items used by the City. The City intends to award to the lowest priced, responsive, responsible bidder(s) on an individual line item basis.

The proposed contract shall extend for a minimum time frame of twelve (12) months, with month to month extension thereafter, at the prices originally bid, upon mutual agreement of both parties. This extension phase is not to exceed twenty-four (24) months. Prior to the end of the initial contract term or during any extension phase of this contract, the successful bidder(s) shall give the City an advanced thirty (30) days written notice if they wish to terminate the contract. During the extension phase of the contract should any product bid have a manufacturer's price increase which applies across the board to all sales of the product, the City shall allow the bidder to increase the bid price by the exact dollar amount of the manufacturer's price increase. Bidder must provide to the City printed documentation from the manufacturer of any such price increase at least thirty (30) days prior to implementing any increase in price. No increase in price shall be allowed during the first six (6) months.

Successful bidder(s) shall not assign this contract to any other party without prior written approval of the City of Birmingham. Contract shall not be assigned to an unsuccessful bidder who was rejected because he was not a responsive or responsible bidder.

The contract(s) shall become effective from the date noted in the Notification of Award letter(s) which will be mailed to the successful bidders(s).

Should other ammunition items currently not shown on the bid form, be required during the life of the contract, the City reserves the right to seek verbal bids from only the responsive respondents of this Invitation to Bid, and to make an award of these additional items to the lowest responsive, responsible bidder(s) for the remaining life of this contract.

The City's standard payment terms are net 30 days from acceptance. Exception may be allowed for discounted early payment, such as 2% 10 net 30 days. **The City will not consider any bids requiring C.O.D. payments.**

Any questions concerning these specifications should be addressed to Charles Lindsey, Purchasing Division, at 205-254-2269, between the hours of 8:00 a.m. & 3:00 p.m. Monday through Friday.

The quantities on the bid form are estimated annual usage only. Merchandise shall be ordered as requirements dictate. The City reserves the right to purchase more or less than these quantities as conditions require, and no bidder shall attempt to hold the quantities shown as firm quantities under this contract(s).

Any bid that imposes a service fee or any other type of fee on any order not exceeding a minimum order quantity or minimum purchase order dollar amount, will be determined a non-responsive bid and will not be considered for award.

All bids submitted are to be F.O.B., Birmingham, Alabama, delivered.

Any bid that stipulates a reversal of freight charges if a minimum quantity or purchase order amount is not ordered, will be determined a non-responsive bid and will not be considered for award.

The City has limited storage space so timely delivery shall be a consideration. The successful bidder(s) shall guarantee full delivery within ten (10) working days of receipt of order.

The City reserves the right to terminate any line item(s) and seek new bids as described in paragraph 5 on page 2 at any time the City determines that the product(s) being supplied is/are failing to perform satisfactorily.

Failure to adhere to any or all terms, conditions and specifications as set forth in the contract may result in the immediate termination of the contract. Should termination occur, the holder of the contract may be declared a "non-responsible vendor". This declaration may result in the rejection of any future bids submitted by the vendor for a period of time to be determined by the City.

The City may require samples of any product before an award is made. Any sample(s) requested must be made available to the City within seventy-two (72) hours of request. Failure to provide the sample(s) within this time frame will result in the rejection of the product(s) from award consideration.

Each bidder is to extend unit prices and provide an extended total for each line item being bid. In order for the bid award to be made that exceeds \$10,000.00 your bid must be accompanied by an acceptable bid bond or check in the amount of \$500.00. Bid bond checks will be returned to all unsuccessful bidders after the formal award is made and to the successful bidder after acceptance of award. Should the successful bidder fail to accept the award, the bid bond or check shall be forfeited.

Bids may be solicited for any item included in this contract, where an immediate/emergency need exists, including large quantities. The decision of the Purchasing Agent as to what constitute a biddable situation shall be final and shall not be construed as a breach of contract.

In the event delivered ammunitions exhibits poor quality such as variations in velocity of same caliber, consistent stoppage, high primers, etc., the vendor agrees to replace the full order of such ammunition, including spent ammunition of not more than one case.

The City will issue purchase order(s) to the successful bidder for the goods and/or services (bid items) that are the subject of the bid. Unless otherwise agreed in a writing that is signed by both parties, the entire agreement between the City and the successful bidder concerning the bid items is comprised of the terms, conditions, specifications and requirements stated in (a) the contemplated purchase order(s), (b) this Invitation to Bid and Specifications and (c) your bid (collectively, the "Contract Requirements"). These writings supersede all former proposals, offers, negotiations, representations or agreements, either written or oral, concerning the provision of vendor's goods and/or services. By acceptance of the City's purchase order(s), the successful vendor agrees to abide by and perform its responsibilities related to the bid items in compliance with the Contract Requirements.

Bids may be solicited for any product included in this contract where an immediate/emergency need exists, including large quantities. The decision of the Purchasing Agent as to what constitutes a biddable situation shall be final and shall not be construed as a breach of contract.

Contract award to purchase the materials covered in this bid document shall be construed under and governed by the laws of the State of Alabama and each party hereto irrevocably agrees to be subject to the jurisdictions of the courts of the State of Alabama.

Partial Shipments: The City as a rule accepts partial shipments. However, vendors should note that the receipt of a partial shipment of ordered goods does not alleviate the vendor's obligations for the complete shipment of goods by the due date as stated within the purchase order. Consistent failure to ship reasonably complete orders will constitute breach of contract and will result in the declaration of the vendor as a "non-responsible vendor" and subject to the aforementioned penalties of such declaration. For the purposes herein, "reasonably complete" shall mean at least 70% of the total quantity ordered by the City and indicated on the purchase order.

Rounding Up or Down of Quantities Shipped: The City as a rule will order whole count units (boxes, cases, etc.) whenever possible. No vendor should round up or down quantities ordered by the City without first receiving approval to do so.

Please Note: For evaluation purposes of ammunition all units of measure are to be each round or unit of measure otherwise specified. The City's purchase order system goes to four decimal places; therefore please round prices to four decimal places.

All deliveries are to be made Monday thru Friday ONLY. No deliveries will be accepted on weekends or holidays (New Year's Day, Martin Luther King Birthday, Good Friday, Memorial Day, 4th of July, Labor Day, Veteran's Day, Thanksgiving and Day After, Christmas Eve, and Christmas).

Vendor (and its employees, agents and any subcontractors) shall not discriminate on the basis of race, color, national origin, or sex in the performance of the services contemplated hereunder. Failure by the Vendor to carry out these requirements is a material breach of its obligations, which may result in its termination or such other remedy as the City deems appropriate.
