CDBG, HOME, HOPWA, AND ESG PROGRAMS**

- \* **December 22, 2013**: Make PY 2014 Alternative Proposal Applications Available and publish Proposed PY 2014 Action Plan for mandatory 30 day comment period. Copies to be sent to current CDBG, ESG, HOME sub recipients, HABD, HUD, City Council Members, and various City departments and both to be posted on the Community Development Department Webpage at [www.birminghamal.gov](http://www.birminghamal.gov).
- \* **January 16, 2014**: PY 2014 Action Plan public hearings to be conducted at 9:30 a.m. and 5:30 p.m. in the City Council Chamber by the Community Development Department.
- \* **January 23, 2014**: PY 2014 Action Plan public hearings to be conducted at 9:30 a.m. and 5:30 p.m. in the City Council Chamber by the Community Development Department.
- \* **January 24, 2014; 4:00 p.m.**: Proposed Action Plan comment period ends. Deadline for the submission of all comments/proposals.
- \* **February 17, 2014**: Community Development Department complete review of PY 2014 proposals and submit them to the Mayor for approval. This is an estimated time frame depending upon the number of proposals received and is subject to change.
- \* **March 12, 2014**: Publication of the Mayor's Recommended PY 2014 Action Plan and Budget for 30 day Citizen Comment and review if substantial amendments have been made to the Proposed Action Plan published in December.
- \* **March 17 through April 7, 2014**: City Council Committee Review of the Mayor's Final PY 2014 Action Plan Budget recommendations. Includes Committee Review(s).
- \* **April 8 or 15, 2014**: Present Proposed PY 2014 Action Plan to the City Council authorizing the Mayor to submit the Action Plan to HUD pending completion of all regulatory requirements.
- \* **April 14, 2014; 4:00 p.m.**: Mayor's Recommended Action Plan comment period ends. Deadline for the submission of all comments/proposals.
- \* **April 16, 2014**: Publication of the Final PY 2014 Action Plan and Budget for 30 day Citizen Comment and review if substantial amendments have been made to the Mayor's Recommended Action Plan published in March.
- \* **May 15, 2014**: Submission of the City's Final PY 2014 Action Plan to HUD and to the State Clearing House for required 45 day review.
- \* **May 19, 2014; 4:00 p.m.**: Final Action Plan comment period ends (if needed).
- \* **July 1, 2014**: PY 2014 Action Plan begins pending receipt of grant agreements from HUD and execution by the Mayor.
