**PY 2012 ACTION PLAN SUBMISSION SCHEDULE FOR
CDBG, HOME, HOPWA, AND ESG PROGRAMS**

- * **December 15, 2011:** Make PY 2012 Alternative Proposal Applications Available and publish Proposed PY 2012 Action Plan for mandatory 30 day comment period. Copies to be sent to current CDBG, ESG, HOME sub recipients, HABD, HUD, City Council Members, and various City departments and both to be posted on the Community Development Department Webpage at www.birminghamal.gov.
- * **January 5, 2012:** PY 2012 Action Plan public hearings to be conducted at 9:30 a.m. and 5:30 p.m. in the City Council Chamber by the Community Development Department.
- * **January 19, 2012:** PY 2012 Action Plan public hearings to be conducted at 9:30 a.m. and 5:30 p.m. in the City Council Chamber by the Community Development Department.
- * **January 27, 2012; 4:00 p.m.:** Proposed Action Plan comment period ends. Deadline for the submission of all comments/proposals.
- * **February 24, 2012:** Community Development Department complete review of PY 2012 proposals and submit them to the Mayor for approval. This is an estimated time frame depending upon the number of proposals received and is subject to change.
- * **March 16, 2012:** Publication of the Mayor's Recommended PY 2012 Action Plan and Budget for 30 day Citizen Comment and review **if substantial amendments** have been made to the Proposed Action Plan published in January.
- * **March 19 through April 9, 2012:** City Council Committee Review of the Mayor's Final PY 2012 Action Plan Budget recommendations. Includes Committee Review(s).
- * **April 10 or 17, 2012:** Present Proposed PY 2012 Action Plan to the City Council authorizing the Mayor to submit the Action Plan to HUD pending completion of all regulatory requirements.
- * **April 19, 2012:** Publication of the Final PY 2012 Action Plan and Budget for 30 day Citizen Comment and review **if substantial amendments** have been made to the Mayor's Recommended Action Plan published in January.
- * **April 23, 2012; 4:00 p.m.:** Mayor's Recommended Action Plan comment period ends. Deadline for the submission of all comments/proposals.
- * **May 15, 2012:** Submission of the City's Final PY 2012 Action Plan to HUD and to the State Clearing House for required 45 day review.
- * **May 21, 2012; 4:00 p.m.:** Final Action Plan comment period ends (if needed).
- * **July 1, 2012:** PY 2012 Action Plan begins pending receipt of grant agreements from HUD and execution by the Mayor.
