Payments may be made by
Cash, Cashier's Check or Money Order

The **court date on your ticket is the deadline for paying your ticket**. Please allow at least seven days after receiving a ticket before attempting to pay it to allow time for processing. The total cost of your ticket is **listed on the back of this form**. We do not accept partial payments. If you pay your ticket at least 48 hours before your court date, the matter is settled, and your name is removed from the court docket. If you **DO NOT** pay your ticket at least 48 hours before your court date you **MUST** appear in court. If you are charged with an offense that is not listed you must appear in court. You will **NOT** pay additional court costs for appearing in court.

FAILURE TO APPEAR OR SETTLE

You will incur additional cost if you do not pay your ticket prior to your court date or appear in court. Your driver's license will be suspended and a warrant may be issued for your arrest.
