On May 2012 City Hall hired one of its newest employees to the Finance Department. Through hard work, perseverance, and education, Ricky Walker is now being

trained to handle his new responsibilities in payroll.

Mr. Walker was born with cerebral Palsy, which is a deficiency or loss of motor control throughout the muscles in the body. He uses a wheelchair for his main mode of mobility but can also use crutches to walk short distances. Despite this disability, Rickey succeeded in attaining a degree in finance from the University of Montevallo where he has acquired the skills necessary for his new position.

Because of his physical limitations, it was assumed that a modified work-space would be necessary to complete day-to-day tasks. After he met with ADA staff and city workers it was found that very few modifications had to be made to his work area. When asked about this, his comment was, "All that stuff was nice but pretty unnecessary." The only piece of adaptive equipment he uses is a keyboard he brought from home that's set up for a left handed person with the number pad located to the left. "I didn't want to stick out like a sore thumb, besides, this is all I really needed" he said.

Before ending the interview he was asked about his expectations now that he's finally working in his chosen profession. Without hesitation he responded by saying, "The people are really nice and I love what I'm doing. I hope to retire from here."



Lakeshore Summer Activities for Children with Disabilities

Summer time is here and the kids are out of school for a long awaited school vacations. Instead of sitting at home playing video games, a lot of kids will be attending summer camps that are chalked full of activities that will keep them occupied, stimulated, and physically active.

Sadly enough, not all of these programs are prepared to meet the needs of kids with disabilities. The Lakeshore Foundation has a lined up a number of programs that address this issue.



The offered camps are:



Camp Strive

This residential camp begins on **June 22 – 24** and will be a weekend of activities such as swimming, adaptive water sking, fishing, and other exciting activities. However, families will be responsible for transportation to and from the campsite.

Camp Jaws

This camp starts on **July 16 – 19** and is actually geared toward amputees and wheelchair users, however, any youth with an ambulatory disability can participate. Participants will be introduced to Paralympics sports including swimming, wheelchair basketball, sitting volleyball, track & field, and tennis. Higher level athletes will help to serve as instructors and mentors for each sport.



Inclusion Camp

This camp starts on **July 23 – 26** and is designed for physically disabled your along with their siblings and friends. The campers will be grouped by age and will participate in activities that focus on recreation, sports, and fitness. In order to participate, hopeful campers must be able to function on their own in a group setting.

With all of these great events taking place, this summer should be fun for every kid for miles around.

News You Can Use: Senior Citizens and Disability Property Tax Exemptions

If you are age 65 or older, or disabled you are eligible for a property tax exemption from Jefferson County. The exemption is not automatic and individuals must file for the exemption. To apply you must bring proof of age (birth certificate or drivers license) and the most recent Federal and State income tax returns to the

Tax Assessor's office between October 1 and December 31 to be eligible for exemption on the next years tax. You must own and occupy a single family residence and you must be 65 years of age or considered disabled as of October 1. To apply for the disability exemption, 2 proofs of disability will be required, (letter from doctor, social security, or company disability letter stating the individual in question is totally and permanently disabled). Total or partial exemption is based on income.

Anyone over age 65 years of age will be entitled to exemption on the state's portion of property tax. This exemption must be claimed in advance. The current tax bill will still need to be paid since property tax is paid in arrears.

NOTE: The exemption must be renewed annually but this could mean a savings of hundreds of dollars to you each year.
