"Notice is hereby given that at its meeting beginning at 9:30 a.m. on Tuesday, October 15, 2013 in the Council Chamber on the Third Floor of Birmingham City Hall, the Council of the City of Birmingham will hear comments from citizens and concerned parties relating to the approval of a plan to modify the existing City of Birmingham Eastern Area Landfill located at 2787 Alton Drive, Birmingham, AL 35210, in accordance with the requirements of § 22-27-48 Code of Alabama (1975). The Eastern Area Landfill is an existing municipal solid waste landfill located on 370 acres off of Alton Road in eastern Jefferson County. The City has previously received host government approval to dispose waste within 48 acres at the Eastern Area Landfill. The City proposes that the host government remove the disposal acreage restriction, allowing the City to potentially use the entire acreage for disposal, subject to regulatory limitations and approval by the Alabama Department of Environmental Management for development of disposal units within the acreage in accordance with the requirements of 40 CFR Parts 257

and 258 (“Subtitle D”); Ala. Admin. Code r. 335-13; and, the City of Birmingham Solid Waste Management Plan. The landfill is currently permitted by the Alabama Department of Environmental Management (ADEM). The proposed modification is relevant to and consistent with the City of Birmingham Solid Waste Management Plan.
