CERTIFICATION

I am applying according to plans submitted herewith (copies of complete plans and profile which are subject to review of the City Engineer) and in accordance with all specifications, codes and ordinances of the City of Birmingham.

It is understood that no work shall be performed without proper inspections by an authorized representative of the Planning, Engineering, and Permits Department and such inspection services will be paid for at a daily rate and scale commensurate with existing wages being paid for such services, which services will be furnished by an inspector on the Department=s payroll and billed to the contractor at the end of each month.

It shall be the duty of the inspector as representative of the City and of the owner or developer to enforce the observance of all codes, ordinances and specifications of the City of Birmingham. Non-conformance with any of these codes, ordinances and specifications shall constitute the authority of the inspector to stop all construction within the jurisdiction of the City Engineer until such codes, ordinances and specifications have been complied with.

It is further understood by the contractor that he is not released from these provisions and will not request payment from the owner or developer until the owner has received a letter from the City Engineer stating that all work performed has been constructed in accordance with the plans filed and specifications applicable thereto, and that the City of Birmingham will accept same for maintenance if work is associated with subdivision improvement.

I hereby certify that I have read this application and that all information contained herein is true. If any portion of this information, either intentionally or unintentionally, is false or is a misrepresentation of the material facts, the permit or process granted will be void. I further certify that if I am not the owner, I have proper authorization from the owner to act as representative on his/her behalf and that I may be required to Provide written documentation of such authorization to the City of Birmingham.

Construction of Sewers and other Improvements in Streets, Section 4-5-113

The fee for a permit required by this article shall be three Hundred dollars (\$300.00); provided, that in the event construction is commenced before a written permit is granted, no permit shall be issued except upon payment of a fee of four hundred dollars (\$400.00).

A Plan Review Fee shall also be required when plans are required to be reviewed before permit issuance. Plan Review Fees are due at the time of application.

The applicant shall provide an estimated permit value at the time of application. Estimated cost shall include the total cost of all work and shall include overhead and profit, engineering and architectural design fees, and be equivalent to the end cost of the project. Detailed estimates and copy of the original executed contract(s) may be required for review to validate the declared scope and/or value of the construction. Final valuation shall be set by the City Engineer.
